Thank you for the call early last week. I appreciate the introduction and being able to put the right folks together.

I was part of a Deer Park transportation committee earlier this year and I learned first hand from Kerri Leliefeld, DP Bus Superintendent, Stacy Sturdevant, DP Asst Bus Superintendent, and their bus drivers the conditions of some of the county road conditions they face. I have included Kerri and Stacy as your primary points of contact for the roads in question. They are the experts for further discussion, and I hope to suggest a proposed field trip if time is available to you. Here's what I know. Some of the conditions are shoulders are eroding away, forcing drivers to drive on the yellow stripes. Some stops have steep of shoulders, making drivers park in the middle of the road before students can get on. Last week, my bus driver, Terri, pulled off as far as she could go and stopped after picking up my daughter because two large semi-trucks where coming from the other direction and were hauling large logging equipment that protruded from the both sides of the trailer. Had she not pulled over, it would have been dangerously close.

The Deer Park Bus transportation facility (509-464-5530) has been have phone outages/issues, so I suggest email at first to reach Kerri and Stacy. At this point, I will step away and hope to hear some future road improvement news Kerri and Stacy are happy with.
